Dear Rector,

Pursuant to Art. 88, para 1, item 6 of the Higher Education Act (HEA), I hereby inform you of the outcome of the programme accreditation procedure performed in respect of **professional field 3.8 "Economics" at the Higher School of Insurance and Finance - Sofia**.

The procedure has been opened by the Standing Committee on Economic Sciences and Management on 29.04.2015 (Protocol № 13) on the request of the Higher School - **incoming ref.** № 677/ 25.08.2014 and incoming ref. № 223/27.03.2015.

At a session held on 24.02.2016 (Protocol Nequive 4), pursuant to Art. 88a, para 4 of HEA and Art. 12, para 6, item 4 of the Statute of the National Evaluation and Accreditation Agency, the Committee's members have adopted the report of the Group of Experts approved by the Accreditation Council on 15.10.2015 (Protocol Ne 23).

As a result of findings from the evaluation performed on **23.03.2016 (Protocol № 6)**, pursuant to Art. 88a, para 5, item 1 of HEA and Art. 38, para 2 of the Statute of the National Evaluation and Accreditation Agency, members of the Standing Committee have voted according to the Criteria system for programme accreditation of professional fields on a scale of one to ten, pursuant to Art. 79, para 1 of the Higher Education Act.

After having summarized the results of the vote, in compliance with the adopted by the Accreditation Council of NEAA "Rules for carrying out voting procedures in respect of accreditation and evaluation of projects", the Standing Committee on Economic Sciences and Management has made the following <u>DECISION</u>:

1. To grant programme accreditation to professional field 3.8 "Economics" at the Higher School of Insurance and Finance – Sofia on the grounds of a total score of: **9.03 (nine point zero three hundredths).**

2. The accreditation shall be valid for a period of SIX years, pursuant to Art. 79, para. 4 of HEA.

**3.** To determine the capacity for training in professional field 3.8 "Economics" at the Higher School of Insurance and Finance – Sofia as follows: **for educational and qualification degree "Bachelor" – 1000 students (including full-time, part-time and distance training), for educational and qualification degree "Master" – 1000 students (including full-time, part-time and distance training).** 

Total for the professional field: 2000 students.

The Standing Committee on Economic Sciences and Management has made the following recommendations:

 The documentation relating to the curriculum of the jointly developed with the University of Sheffield specialties to be brought in line with the requirements of Ordinance № 21 dd. 30 September 2004 for the application of credit transfer and accumulation system in higher education institutions, providing for the allocation of 60 credits per academic year, 30 credits per semester.

Term: September, 2016.

2. The documentation relating to the curriculum of specialties in professional field 3.8 "Economics" of the educational and qualification degree "Bachelor" to be brought in line with the requirements of the Physical Education and Sports Act, providing for 60 hours annually for the entire course of studies of compulsory classes in physical education and sports.

Term: September, 2016.

3. The documentation relating to the curriculum of specialties in professional field 3.8 "Economics" of the educational and qualification degree "Bachelor" implemented in the form of distance learning to be brought in line with the Ordinance on state requirements for the organization of distance learning in higher education institutions in respect of ensuring equality between the distance learning and the full-time training.

Term: September, 2016.

4. The documentation relating to the curriculum of specialties in professional field 3.8 "Economics" of the educational and qualification degree "Master" to be brought in line with the provisions of HEA and the Ordinance on the state requirements for the acquision of higher education in educational and qualification degrees "Bachelor', "Master" and "Specialist", for carrying out training in compulsory, elective and optional subjects.

## Term: September, 2016.

5. For all specialties of the educational and qualification degree "Master" curricula are to be developed and approved in respect of different categories of students (those having the educational and qualification degree "Bachelor" in the professional field 3.8, the educational and qualification degree "Bachelor" or "Master" in a non-economic professional field or the educational and qualification degree "Professional Bachelor" in the professional field 3.8 "Economics").
