1. Information about the dissertation

Dr. Olejazh graduated from a military school in the period 1986-1990, received a master's degree in economics from the University of Economics in Warsaw. He holds a PhD in logistics from the University of Rzeszow, Poland, extensive experience as a lecturer at the University of Rzeszow and an army officer in charge of supplies in various military units. He has participated in several international military missions and operations, has been awarded high military honors for excellent service, with a lasting interest in military logistics and numerous publications, as evidenced by the materials attached to the dissertation.

2. General characteristics of the presented dissertation

The dissertation consists of an introduction, five chapters containing thirty-six subsections, conclusions, Bibliography, List of figures and List of tables. Its volume is a total of 257 pages, of which 240 pages are body text. The list of references contains over 200 titles, mainly in Polish. There are over 400 references in the work, which correctly reflect the used literature.

The object, subject, working hypothesis with expected results, main research goals and expected research methods are correctly defined.

3. Evaluation of the scientific and scientific-applied contributions

The doctoral student states in the abstract 4 contributions and 10 main conclusions. The reviewer accepts these contributions in principle with the remark that the contributions can be formulated more clearly and emphasize their scientific, scientific methodological or scientifically applied nature.

4. Evaluation of the obtained scientific and scientific-applied results according to scientific and scientometric criteria and requirements of VUZF and the Republic of Poland.

The material is well structured, sufficient sources have been used, an empirical study has been conducted with the relevant results. The work is written in good style; the basic requirements are met.

The author has conducted independent research with empirical analysis. The analysis itself serves to identify the causes and at the same time to test the author's ideas.

In accordance with ZRASRB, a dissertation and an abstract are presented, the main contributions of the author are indicated. The total extended number of publications related to the dissertation is a total of 48, of which 3 independent monographs. There are 10 independent publications, the rest are co-authored, mainly in Polish and English. The research has been published in respected publications presented at authoritative scientific forums. Dr. Olejazh fully meets the national requirements of Poland, and in some respects significantly exceeds the set minimum thresholds.

5. Evaluation of the dissertation publications

The provided materials reflect the topic of the research, present the main contributions of the author and acquaint the public with the main ideas of the scientific work.

6. Evaluation of the abstract

The abstract gives a sufficiently complete picture of the goals, objectives, content and results of the study.

7. Critical remarks, recommendations and questions

The conducted dissertation research has many merits. Much effort has been made to present and analyze the logistics system of the Polish Armed Forces. The presented notes and recommendations aim to improve the work and help in future research of the dissertation. The scope and limitations are not defined in the study, although Poland is implicitly implied. The main goal of the research in the direction of developing an efficient and optimal logistics system of the Polish Armed Forces could be more precisely formulated. In fact, the author does just such research and recommendations. Questions:

-How could the author's concepts be used within the European Union? Does the author have comparative studies with other NATO countries and in particular with Bulgaria?

Conclusion

The dissertation fully meets the requirements of the LRA and the Regulations for its implementation. There is our own research, structured in an appropriate way, with outstanding contributions in different directions.

That is why I confidently give a positive assessment of the dissertation on the topic: "FINANCIAL EFFICIENCY OF THE LOGISTIC SUPPORT OF THE POLISH ARMY" and I recommend to the esteemed members of the Scientific Jury to award the degree of "Doctor of Science" to Dr. Tadeusz Olejaj.
