### 1. General description of the presented materials

# 2. Relevance of the topic and expediency of the set goals and objectives

Recent years have seen an increase in the use of arbitration in the financial sector. The increasing complexity of financial transactions and financial products has an impact on the use of arbitration. Although the technical knowledge of judges in banking and finance varies from one legal system to another, there is a perception that arbitration meets the opinion expressed in the financial business that disputes should be resolved by experts in the field.

The purpose of researching a doctoral dissertation is to prove that arbitration is a form of alternative dispute resolution that offers a fair resolution of disputes by an impartial third party without undue cost or delay.

## 3. Knowledge of the problem

The author has made an extensive, thorough, and correct analysis of the various issues addressed in the work, allowing for correct conclusions. For the preparation of this publication, the author analyzed 115 source materials (including those in foreign languages), especially acts of domestic and international law, specialized literature on the subject, statistical data, and source materials of central authorities.

Due to the nature of the matter being processed in the doctoral dissertation, temporal matter is researched in the period from 2000 to 2021 to determine how the conduct of arbitration as a form of alternative dispute resolution has progressed.

### 4. Research methodology

With a view to the stated purpose of the work and verification of the adopted research hypotheses, the following research methods were adopted:

- ➤ *historical* applying this method historically determines the emergence and development of arbitration as a form of alternative dispute resolution.
- ➤ *content Analysis* applying this method analyses the results of conducting arbitration as a form of alternative dispute resolution
- > comparative method (comparative) with the application of this, a comparative perception of the experiences in discovering the functioning of arbitration as a form of alternative dispute resolution is performed, domestically and internationally.
- > statistical method by applying this method, the results of the implementation of arbitration as a form of alternative dispute resolution are processed.
- > synthesis with the help of this method the data obtained with the help of the previous methods are combined.
- ➤ The preparation of the doctoral dissertation is based on data provided by international literature.

The author presented the results of the research conducted and interpreted them correctly.

### 5. Characteristics and evaluation of the dissertation

**The dissertation** consists of 161 pages, of which 152 are the main text and the literature used to prepare this publication constitutes 115 source items.

The study has an introduction, four chapters, a conclusion, and a bibliography.

#### Purpose and scope of the study

The main goal of the doctoral dissertation is to prove that arbitration is a form of alternative dispute resolution that offers a fair resolution of disputes by an impartial third party without undue cost or delay.

Financial institutions value the ability of national courts to quickly dispose of claims that have little basis or prospect of success, or are undisputed debt claims, through relatively quick and inexpensive processes such as aggregate or default. Historically, this has been one of the main reasons for financial institutions to prefer litigation to arbitration.

The increasing complexity and sophistication of financial markets and financial products all call for a larger variety and more sophisticated methods of dispute resolution in cross-border banking and finance transactions. Recent years have seen an increase in the use of arbitration in the financial sector. Arbitration is sometimes considered more appropriate for resolving disputes in some industrial sectors than in others. Although long used in transportation, insurance and construction, it has traditionally been less popular with banks and other financial institutions.

# 6. Contributions and significance of development for science and practice

The problem posed by **Xhenis Sina** is interdisciplinary and entirely refers to the current achievements and needs of science and practice, which deserves toappreciate the author's contribution. The chosen research problem is not an easy problem to study due to its interdisciplinary and multifaceted nature.

- 3. Proposal of activities for the use of arbitration in the resolution of financial disputes.
- 4. Proposal for the improvement of contractual conditions for arbitration of financial disputes between business organizations.
- 5. Developed measures for the promotion of arbitration mediation and resolution of financial disputes without the use of court proceedings.
- 6. Proposed and designed activities for the promotion of arbitration in the resolution of financial disputes. through Hi-tech communication systems.
- 7. The methods and aspects of arbitration in the resolution of financial disputes have been researched and empirically proven.

8. Research was conducted to improve coordination and cooperation between the competent authorities in the implementation of arbitration in the resolution of financial disputes.

## 7. Evaluation of dissertation publications

The results of the scientific research are reflected in 3 publications prepared independently. They testify to the doctoral student's long-standing and deep scientific interest in tax issues and the fact that the prepared dissertation is the author's work.

Also, this kind of scientific research implies more financial and economic analysis of data, statistical information, comparison and contrast, conclusions, generalizations, models and original contributions to the studied issues.

I recommend presenting the results in specialized international publications with IF / IR, allowing higher visibility of scientific results and creating conditions for more intensive

citations.

12. Personal impressions

I do not know the doctoral student personally. We do not have joint publications and

developments.

My impressions come from the dissertation, the author's summary of professional

accomplishments, and dissertation publications. They show a serious and erudite researcher, a

bona fide scientist with an extensive theoretical background and a proven ability for

independent research.
