## 3. General characteristics and evaluation of the PhD candidate thesis

The PhD thesis covers a total of 195 pages. It consists of table of contents, introduction, three chapters, conclusion, reference list, tables and figures, two appendices. The reference list consists of 194 sources. There are 40 figures and 3 tables. The structure and volume of pages meet the requirements for such type of research.

# 4. Contributions and significance of the PhD thesis for the development of science and practice

I accept three scientific contributions of the thesis:

- classification and categorization of the concepts in the cognitive process,
- perceiving the management process as a continuous process, which is developed together with the development of the organization,

• implementing analysis in the intersection of the organization – competence – finances relationship.

## 5. Evaluation of the publications in relation to the topic of the PhD thesis

The PhD student has presented a total of ten (10) articles, published in non-refereed peer-reviewed journals in edited collective volumes.

## 6. Evaluation of the fulfillment of the minimum national requirements

I concern that the candidate meets the minimum national requirements according to the documents submitted and in accordance with the regulations of VUZF.

It is made an inquiry about the candidate's fulfillment of the minimum national requirements for obtaining the educational and scientific degree "Doctor" in the professional field 3.8. Economy by representatives of VUZF, who have checked the documents.

#### 7. Abstract of the PhD thesis

The content and quality of the abstract is good. It is written in accordance with the relevant regulations and presents the main results, achieved in the thesis.

## 8. Critical remarks and recommendations

There could be made some critical remarks and recommendations to the research:

- 1. The stated three hypothesis of the research are rather tasks of the thesis. They do not contain controversial statements that need to be proved;
- 2. The main hypothesis of the research is formulated too generally. In this way the main contributions of the author could not be well outlined;
- 3. The applied statistical methods are very poorly used. At the same time, there are many sections in the thesis where generally known equations are used, for example section 2.6. "Financial indicators of the project" (pp.112-118).

However, the conducted research in a great extent has achieved the goals that have been set in its introduction section.

#### **CONCLUSION**
